The Judicial Test(Higher) Examination will have three parts viz. Part-I, Part-II and Part-III with five papers in each part. The name of the papers and the division of marks are given below. The test will be conducted by the High Court during every mid-summer vacation. The duration of the written test for each paper will be three hours. The maximum mark for each paper will be 100. A minimum of 40 marks is required for pass in each paper. When applying for the first time, the candidates have to apply for all the five papers of the part they are applying for. Those who clear this test will be treated as equal to those who possess LL.B Degree for the purpose of promotion/transfer to higher posts except the post of Registrar.
