For the purpose of satisfying the rules of reservation of appointment to Scheduled Castes,Scheduled Tribes, Other Backward Classes,Economically Weaker Section and Differently Abled, necessary supplementary list is prepared by including sufficient number of candidates from lower mark ranges in the order of merit of the candidates belonging to such classes.

Note :- (4) Candidates included in the Short List should present and produce in person the original documents for One Time Verification and Interview. Date,time and Venue of OTR Verification and Interview will be intimated in due course through profile message and SMS.

Note :- (5) Candidates belonging to Other Backward Classes included in the Short List are required to produce Non Creamy Layer Certificate as per G.O.(P) No.81/2009/SCSTDD dated 26.09.2009, SC/ST candidates are required to produce Community Certificate in Form III or digitally signed by the Revenue Authority not below the rank of Tahsildar and Candidates belonging to Economically Weaker Section(EWS) as per GO(MS)No.2/2020/P&ARD dated.12.02.2020 are required to produce certificate issued by the competent Revenue Authorities at the time of OTR verification.

Note :- (6) According to the existing procedure, revaluation of answer scripts is not allowed but answer scripts can be rechecked after the publication of Ranked List. Detailed instructions will be published in the Ranked List to be published for the post.

Note :- (7) Copy of answer scripts of the OMR Test held on 24-07-2023 will be issued to those candidates who, apply for the same remitting the prescribed fee after approval of the Ranked List. No candidates are invalidated as per Notification No : ER II (3)4707/2023/EW dated 18-11-2023
