<text></text>	 Why in news? A deep depression currently situated over Saurashtra and Kachchh regions of Gujarat is expected to intensify into a cyclonic storm (Cyclone Asna). Cyclone Asna would be the first cyclone to form in August in the North Indian Ocean (NIO) region since 1981 and the first in the Arabian Sea since 1976. Key Points: A cyclone is a large-scale system of air that rotates around the center of a low-pressure area. The cyclone forms around the low-pressure area, called a depression, along a zone of cold and warm air exchange called the 'eye wall'. The eye is the central and calmest part of the cyclone. The air circulates inward in an: anticlockwise direction in the Northern hemisphere clockwise in the Southern hemisphere.
Shanghai Cooperation Organization (SCO)	 Why in news? India has yet to take a decision on Pakistan's invitation to the SCO meet. Key Points: It is an intergovernmental political, economic, and security alliance founded in 2001 by Kazakhstan, China, Kyrgyzstan, Russia, Uzbekistan, and Tajikistan. The first summit was held in Shanghai, China, in 2001. The SCO aims to promote cooperation and mutual support in areas such as trade, investment, energy, transportation, and security. Headquarters: Beijing, China.
