**Chief Medical Superintendent, Mumbai Division,** Western Railway will be conducting Telephonic/online interview for filling-up the posts of Contract Medical Practitioners on full-time contract basis upto period of one year.

# For GDMOs & Specialists from open market

The engagement will be offered purely on contract basis for a period of one year or less from the date of contract, which can be renewed as a fresh contract on year to year basis, not extendable beyond 12 terms or till attaining the age of 65 years or till such time Doctors selected by UPSC become available, whichever is earlier.

# For GDMOs & Specialists from Retired Doctors of Railways, State & Central Government

The engagement will be offered purely on contract basis for a period of one year or less from the date of contract, which can be renewed as a fresh contract on year to year basis, not extendable beyond 07 terms subject to attaining the age of 67 years or till such time Doctors selected by UPSC become available, whichever is earlier.

#### **Educational / Professional Qualifications**

For Specialists-

- 1. Degree in medicine i.e. MBBS recognized by the Medical Council of India.
- 2. A post Graduate qualification/DNB in the relevant subject/field recognized by the Medical Council of India/ State Medical Council.
- 3. Three years experience in Clinical work after Post graduation in the specialty concerned as on the date of interview is desirable.

#### For GDMO-

1. Degree in medicine i.e. MBBS recognized by the Medical Council of India.

# Percentage of reservation between UR, SC, ST and OBC as per recruitment rules will be maintained.

Age relaxation for SC/ST/Ex-servicemen: 5 yrs. And for OBC: 3 yrs.

Retired Govt Medical Officers of State Government and Central Government Doctors upto the age of 65 years may apply for CMP against existing regular vacancies on a fixed remuneration of Rs 46,000/P.M (subject to the condition that remuneration plus pension drawn by Retired government doctors should not exceed the last pay drawn).

Candidates should have requisite academic qualification on the date of interview. Those who are appearing at and/or awaiting results of final examination are not eligible. Academic and Technical Qualification must be from a recognized Institution/Board, otherwise candidature will be rejected. Candidates having higher qualification may also apply & indicate the details.

The vacancies indicated may vary in number and place, depending on fresh sanctions received, resignations being given by existing candidates, etc. **There may be waitlisted / stand by candidates against the notified panel / select list who may be engaged as ner the necessity** 

#### **Terms and condition**

- 1. The selected Candidate will be engaged on contract terms for a period up to one year from the date of Engagement subject to extension of validity of the Scheme for contractual appointment of CMP by Railway Board. The engagement of the above candidate is a stop gap arrangement and will not count as service.
- 2. Engagement on Contract basis of the candidates will be subject to their being found suitable in order of merit by Selection Committee. The candidates found suitable against the requirement of vacancy in order of merit will be sent for Medical Test as per rules.
- 3. The decision of this office in all matters relating to eligibility, acceptance or rejection of the applications, penalty for false information, selection, and allotment of posts to selected candidates will be final and binding on the candidates and no enquiry or correspondence will be entertained in this connection. Candidates who submits forged caste certificate for securing eligibility, shall be liable for rejection of his/her candidature for the particular post for which he/she has applied.
- 4. Contract can be terminated by the Railway at any time during the contract period by giving 15 days notice without assigning any reason as per the terms and conditions laid down vide railway Board's letter No. 96/E(GR)II/9/16 dated 23.02.2000 and No. 2008/E(GR)II/1/1 dated 16.07.2012.
- 5. Contract Medical Practitioner Candidate who enters into contract with the Railway will not have any claim or right for his/her continuity in service or automatic extension of the term of contract. Services rendered as full time contract will not have any right in respect of considering of their period in regular selection through *UPSC* nor will it confer any right for regularization or absorption. Candidates while applying should indicate past service rendered, if any including the period of contract put in by them on Indian Railway.
- 6. The CMP shall undergo a Medical examination, before the contract is entered into, for his/her fitness to perform the work awarded to him/her.
- 7. Interview of the short listed candidates will be done by online/Telephonic Interview mode.
- 8. No private practice or any other employment will be permitted during the subsistence of the contract period. <u>No Objection Certificate</u> If working NOC from Current employer is required.
- 9. Appearance in telephonic / online interview will not vest any right upon the candidate to be engaged and no reason will be sited or communication made in the event of candidate not selected.
- 10. The Railway Administration reserves the right to deploy the candidate anywhere on the Division/Unit depending upon the exigency of service. Refusal otherwise on the part of the candidate shall be deemed to be misconduct.
- 11. The engaged CMP shall not perform administrative work like preemployment or periodical medical examinations, sanction of leave to Gr C and Gr D staff and certification with respect to food items considered unfit for human consumption, etc. However, the CMP shall be allowed to permit Gr C and Gr D staff casual leave if sought, for 03 days or less at a stretch.

- 12. The CMP will not have any financial powers.
- 13. Normally Sundays and National Holidays will be off and in addition authorized absence without detriment to the terms shall be allowed at the rate of two days per month to be availed any time during the contract to the extent earned by the CMP till such time.
- 14. CMP shall issue sick/fitness certificates for a period upto 7 days, beyond which the certificate so issued by him/her should be countersigned by a regular Railway Medical Officer available at the nearest Hospital/dispensary/Health unit.
