	<ul> <li>About ISO:</li> <li>Organization: International Sugar Organization (ISO)</li> <li>Establishment: Founded in 1968; affiliated with the United Nations.</li> <li>Membership: Comprises approximately 85 countries, representing</li> </ul>
	nearly 90% of global sugar production.
	<ul> <li>Mandate:         <ul> <li>Foster collaboration among major sugar producing, consuming, and trading nations.</li> <li>Address issues relevant to the sugar sector through a progressive approach.</li> <li>Biofuels Focus: Engages in work related to biofuels, particularly ethanol, with sugarcane as a significant feedstock.</li> </ul> </li> <li>Key Functions:         <ul> <li>Administer the 1992 International Sugar Agreement (ISA).</li> <li>Enhance international cooperation on sugar-related matters.</li> <li>Serve as a forum for intergovernmental consultations on sugar and strategies to enhance the global sugar market and other sweeteners to facilitate trade.</li> </ul> </li> </ul>
	<ul> <li>Promote increased demand for sugar, including for non- traditional uses.</li> </ul>

		• The election for a permanent Speaker is scheduled for June 26th,	
			as determined by the President.
			About Speaker of Lok Sabha:
			Role Definition:
			<ul> <li>The Speaker of the Lok Sabha is responsible for conducting</li> </ul>
			the proceedings of the house in an impartial manner.
			$\circ$ The Speaker's role is crucial for maintaining order and
			facilitating legislative discussions.
			Election Procedure:
			<ul> <li>As per the Article 93 of the Constitution, the Speaker of the</li> </ul>
			Lok Sabha is elected on simple majority.
			$\circ$ It means that a candidate who receives more than half the
			votes from the members present in the House will be elected
			as the Speaker.
			• Eligibility:
			<ul> <li>Any member of the Lok Sabha can be nominated for the</li> </ul>
			role of the Speaker.
			$\circ$ Typically, the <b>ruling party or coalition nominates a</b>
			candidate for this position.
			Term of Office:
			<ul> <li>The Speaker holds office from the date of their election</li> </ul>
			until the <b>dissolution of the Lok Sabha</b> , unless they resign or
			are removed earlier.
		Removal:	
			<ul> <li>The Speaker can be removed from office by a resolution</li> </ul>
			passed by the Lok Sabha.
			<ul> <li>Such a resolution requires a <b>14-day prior notice</b>.</li> </ul>

rises	<ul> <li>India's external debt rises \$39.7 bn YoY to \$663.8 bn.</li> </ul>
	Key points:
	Increase in Debt:
	$\circ$ Valuation effect due to the appreciation of the U.S. dollar
	against major currencies contributed to this increase.
	Composition:
	• <b>Long-term debt</b> : \$505.5 billion, up by \$9.6 billion from end-
	March 2023.
	• <b>Short-term debt</b> : 19.6% of total external debt, down from
	20.6% at end-March 2023.
	<ul> <li>U.S. dollar-denominated debt: Remains the largest</li> </ul>
	component at 54.4%.
	• <b>Other components</b> include debt denominated in Indian rupee,
	SDR, yen, and euro
	<ul> <li>India's external debt remains a significant economic indicator,</li> </ul>
	reflecting the country's financial obligations and international
	economic relations.





Priority Sector	Why in the news?
Lending (PSL)	• The Reserve Bank of India (RBI) has updated its priority sector lending guidelines, motivating banks to offer smaller loans in economically disadvantaged districts where the average loan size is typically low.
	About PSL:
	<ul> <li>Objective: Priority Sector Lending mandates banks to allocate a minimum portion of their loans to sectors deemed crucial for development and those that typically struggle to access financing.</li> <li>Administration: Administered by the Reserve Bank of India (RBI), which regularly updates eligible sectors and lending limits.</li> <li>Eligible Sectors:         <ul> <li>Agriculture</li> <li>Micro, Small, and Medium Enterprises (MSMEs)</li> <li>Education</li> <li>Housing</li> <li>Social Infrastructure</li> <li>Renewable Energy</li> </ul> </li> </ul>
	<ul> <li>Other prioritized sectors</li> </ul>
	Lending Targets:
	<ul> <li>Domestic Scheduled Commercial Banks (SCBs) and Foreign Banks (with ≥20 branches): 40% of Adjusted Net Bank Credit (ANBC) or Credit Equivalent Amount of Off-Balance Sheet Exposure (CEOBE), whichever is higher.</li> <li>Foreign Banks (with &lt;20 branches): 40% of ANBC or CEOBE, with up to 32% for export lending and at least 8% for other priority sectors.</li> </ul>





	<ul> <li>Regional Rural Banks and Small Finance Banks: 75% of ANBC or CEOBE.</li> <li>Primary Urban Co-operative Banks (UCBs): Currently 40%, increasing to 75% by FY 2025-26.</li> <li>Priority Sector Lending Certificates (PSLCs):         <ul> <li>Instruments that banks can purchase or sell to meet PSL targets.</li> <li>Helps banks manage shortfalls and incentivizes lending beyond minimum requirements to priority sectors.</li> </ul> </li> </ul>
World Craft City	<ul> <li>Why in the news?</li> <li>Srinagar has recently been recognized as a World Craft City by the World Crafts Council.</li> <li>About World Craft City: <ul> <li>Launched in 2014 by the World Crafts Council AISBL (WCC-International).</li> <li>Recognizes the significant role of local authorities, craftspeople, and communities in cultural, economic, and social development.</li> <li>Establishes a global network of craft cities, supporting the creative economy.</li> <li>Indian cities recognized under the World Craft City Programme: <ul> <li>Jaipur (Rajasthan),</li> <li>Mammalapuram (Tamil Nadu), and</li> <li>Mysore (Karnataka).</li> </ul> </li> </ul></li></ul>
