

	<ul> <li>Objective: Promote literacy among non-literates aged 15 and above across all States and Union Territories.</li> <li>Target: Onboard 1 crore learners per year aged 15+ across all States and UTs.</li> <li>Components:         <ul> <li>Foundational Literacy and Numeracy</li> <li>Critical Life Skills: Includes financial, digital, legal literacy, healthcare, childcare, education, family welfare, etc.</li> <li>Basic Education: Preparatory (classes 3-5),</li> </ul> </li> </ul>
	middle (classes 6-8), and secondary stage (classes 9-12) equivalency.
	<ul> <li>Vocational Skills: Continuous skill development for local employment.</li> </ul>
	<ul> <li>Continuing Education: Courses in arts, sciences, technology, culture, sports, and other topics of interest.</li> </ul>
	<ul> <li>Definition of Literacy: Ability to read, write, compute, and apply critical life skills like digital and financial literacy.</li> </ul>
	<ul> <li>Full Literacy Goal: Achieving 95% literacy in a State or UT.</li> </ul>
	<ul> <li>Assessment: Literacy is confirmed after passing the Foundational Literacy and Numeracy Assessment Test (FLNAT).</li> </ul>







India Launches World's First Mobile Hybrid Rocket: RHUM-1	<ul> <li>About RHUMI-1:</li> <li>India's First Reusable Hybrid Rocket: Developed by Tamil Nadu-based startup Space Zone India in collaboration with Martin Group.</li> <li>Innovative Hybrid Propulsion System: Combines the advantages of both liquid and solid fuels, using a hybrid design with solid propellant and liquid oxidizer.</li> <li>Safety and Efficiency: The hybrid design reduces the risk of accidental detonation by combining components only during combustion, leading to improved efficiency and reduced operational costs.</li> <li>Eco-friendly Technology: Features a CO<sub>2</sub> triggered parachute system for safe recovery of rocket components and is free of fireworks, using no Trinitrotoluene (TNT).</li> </ul>

	<ul> <li>About Exotic Pets:</li> <li>Definition of Exotic Species: Animals or plants moved from their natural habitat to a new location, often due to human activities.</li> <li>Criteria for Reporting and Registration (Living Animal Species Rules, 2024): Individuals possessing species listed under Schedule IV of the Wild Life (Protection) Act, 1972, must report and register them.</li> <li>Wild Life (Protection) Amendment Act, 2022: Mandates the registration of possession, transfer, birth,</li> </ul>

Plea Bargaining	<ul> <li>Why in the news?</li> <li>Nearly two decades after its introduction, the use of plea bargaining in India remains limited, according to a recent report by the Union Ministry of Law and Justice.</li> <li>About Plea Bargaining: <ul> <li>Definition: A process where a defendant pleads guilty in exchange for a concession from the prosecutor or court, such as a reduced sentence, lesser charge, or dropped charges.</li> <li>Objective: To resolve criminal cases without a trial, saving time, resources, and expenses for both the prosecution and the defendant.</li> <li>Plea Bargaining in India: <ul> <li>Incorporation: Introduced into the Code of Criminal Procedure (CrPC) in 2005.</li> <li>Applicability: <ul> <li>Applicable to offences punishable by up to seven years of imprisonment.</li> <li>Excludes cases involving crimes against women, children, or socio-economic offences.</li> <li>Court's Discretion: <ul> <li>The court can accept or reject the plea-bargaining agreement if deemed unjust or unreasonable.</li> </ul> </li> </ul></li></ul></li></ul></li></ul>








