In pursuance of DoPT OM dated 31.1.19 which introduced the reservation for EWS candidates in direct recruitment in civil posts and services, the candidature of all EWS candidates has been kept provisional subject to the verification of the veracity of the Income and Asset certificate submitted by the candidate through the Certificate Issuing Authority.

6. It may also be clarified here that qualifying in the Interview & submission of AF & SSQ does not confer any right to the candidate to claim his/her candidature for the post. The final selection is further subject to satisfactory completion of character & antecedents verification, medical examination etc & fulfillment of other eligibility conditions in terms of age limit, qualification, category, etc.
