- ii) Besides fulfilling the above qualifications, the candidate must have cleared the National Eligibility Test (NET) conducted by the UGC or the CSIR, or a similar test accredited by the UGC, like SLET/SET or who are or have been awarded a Ph. D. Degree in accordance with the University Grants Commission (Minimum Standards and Procedure for Award of M.Phil/Ph.D. Degree) Regulations, 2009 or 2016 and their amendments from time to time as the case may be exempted from NET/SLET/SET:

  Provided the candidates registered for the Ph.D. programme prior to July 11, 2009, shell

The Ph.D. degree has been obtained from a foreign university/institution with a ranking among top 500 in the World University Ranking (at any time) by any one of the following: (i) Quacquarelli Symonds (QS) (ii) the Times Higher Education (THE) or (iii) the Academic Ranking of World Universities (ARWU) of the Shanghai Jiao Tong University (Shanghai).

# BEFORE APPLYING FOR THE POST, THE CANDIDATES SHOULD GO THROUGH THE INSTRUCTIONS/CONDITIONS CAREFULLY

#### GENERAL INSTRUCTIONS/CONDITIONS

- 1. In-service candidates shall route their applications, through proper channel. However, candidates are advised to submit an advance copy of the application form well before the last date. They will however, be considered for interview only after their applications through proper channel are received in the University.
- A minimum of 55% marks (or an equivalent grade in a point-scale, wherever the grading system is followed) at the Master's level shall be the essential qualification for direct recruitment of teachers and other equivalent cadres at any level.
  - A relaxation of 5% shall be allowed at the Bachelor's as well as at the Master's level for the candidates belonging to Scheduled Caste/Scheduled Tribe/Backward Classes 'A' & 'B' (Noncreamy Layer) of Haryana/Differently- abled (a) Blindness and low vision; (b) Deaf and Hard of Hearing; (c) Locomotor disability including cerebral palsy, leprosy cured, dwarfism, acidattack victims and muscular dystrophy; (d) Autism, intellectual disability, specific learning disability and mental illness; (e) Multiple disabilities from amongst persons under (a) to (d) including deaf-blindness) for the purpose of eligibility and assessing good academic record for direct recruitment. The eligibility marks of 55% marks (or an equivalent grade in a point scale wherever the grading system is followed) and the relaxation of 5% to the categories mentioned above are permissible, based only on the qualifying marks without including any grace mark procedure.
- 3. A relaxation of 5% shall be provided, (from 55% to 50% of the marks) to the Ph.D. Degree holders who have obtained their Master's Degree prior to 19 September, 1991.
- 4. A relevant grade which is regarded as equivalent of 55%, wherever the grading system is followed by a recognized university, at the Master's level shall also be considered valid.
- 5. University reserves the right of deciding the disciplines as concerned/allied/ relevant while scrutinizing the applications. The decision of the university shall be final and binding for the candidate.
- 6. The time taken by candidates to acquire M.Phil. and / or Ph.D. Degree shall not be considered as teaching/ research experience to be claimed for appointment to the teaching positions. Further, the period of active service spent on pursuing Research Degree simultaneously with teaching assignment without taking any kind of leave, shall be counted as teaching experience for the purpose of direct recruitment/ promotion. Regular faculty members upto twenty per cent of the total faculty strength (excluding faculty on medical/ maternity leave) may be allowed by their respective institutions to take study leave for pursuing Ph.D. degree.
- 7. a) The benefit of reservation will be given only to Haryana domicile candidates. The candidates belong to SC/BC/ESM/PwBD/EWS category are required to submit SC/BC/ESM/PwBD/EWS certificate duly issued by the competent authority of Haryana only. Only such PwBD candidates would be eligible for reservation in services/posts who suffer 40% relevant disability or more.
  - b) Likewise, the Eligible Sports Person (ESP) are required to submit self-attested photocopy of the Sports Gradation Certificate as per Government instructions duly issued by the competent authority. ESM/DESM/DFF(s) are required to submit self-attested photocopy of the Valid Eligibility Certificate duly issued by the respective Zila Sainik Board. EWS (Economically Weaker Section) candidates are required to submit self-attested photocopy of Certificate as per instructions of the Haryana Government.

- 12. The prescribed qualifications and experience are minimum and mere possession of the same will not entitle a candidate for being called for interview. Stringent criteria may be applied by the University for short-listing the candidates to be called for interview.

Shortlisted candidates are required to prepare a Power-Point presentation of 7 to 10 minutes' duration related to their research area/interest to be presented at the time of Interview.

The qualifications as prescribed by the UGC/State Govt. from time to time shall be applicable.
