- The Advertisement to fill up 112 (One Hundred and Twelve) posts of Primary and Upper Primary School Teachers (subject wise) is in compliance to Court Order dated 22/10/2019 of Hon'ble CAT – Mumbai bench in OA No. 345 of 2015 wherein it has been directed to conduct Written Test by quashing selection list dated 4th March, 2015.
- This advertisement is in supersession of the Advertisement No. ADE/DP/DMN/Recruit-Pri/Up.Pri. Tr./2014-15/757 Dated 8th October, 2014 and Corrigendum No. DE/ADM/Recruit Pry./Up.Pry.Tr./2014-15/1265 Dated 22nd December, 2014.
- 3) The candidate who had applied and were eligible against advertisement No. ADE/DP/DMN/Recruit-Pri/ Up.Pri. Tr./2014-15/757 Dated 8th October, 2014 and Corrigendum No. DE/ADM/Recruit Pry./Up.Pry.Tr./ 2014-15/1265 Dated 22nd December, 2014, will be considered eligible for this advertisement, in case they apply against this advertisement also. - 4) The detailed qualification for the posts of Primary / Upper Primary School Teacher as under:
 - a) For primary school, the candidates must have cleared TET-I and for upper primary school candidates must have cleared TET-II in respective subjects
- 5) In case:
 - i) Candidate applies for Upper Primary School Teacher (Maths/ Science subjects), the applicant should be B. Sc. in (Maths / Science / Allied Subjects).
 - ii) Candidate applies for Upper Primary School Teacher (Social Science subjects), the applicant should be B. A. in (Social Science / Allied Subjects)
 - iii) Candidate applies for Upper Primary School Teacher (Language subjects) the applicant should be B. A. in (Gujarati / English).
- 6) The online written exam for the posts of Primary School Teacher & Upper Primary School Teachers will be conducted in bilingual medium i.e. English and Gujarati. The Candidate can choose any of the medium. However one section on English Language proficiency may be included for all these posts since English is taught as first / second /compulsory language in all Primary Schools of the U. T. For the post of Language Subject of Upper Primary School Teacher, the question paper will be in respective language i.e. English / Gujarati only.
- 7) Online applications successfully filled through the website daman.nic.in/ojas within the stipulated time limit shall only be considered. The candidates are advised to fill their active e-mail address and mobile number in the online application as all the correspondence will be made by SSB or the respective department including the offer of appointment etc. through email and /or SMS. - 8) The written examination will be Computer based. The marks for preparation of Merit List will be awarded only for Written Examination. No other marks will be awarded.
- 9) The exam centre allotted to the candidate will be final and the admit card issued will be valid only for the centre allotted/mentioned in the admit card and no request for change of centre at any stage of the selection process will be entertained. However, the allotment/ change of centre to the candidate will be at the sole discretion of the Board.
- 10)The Merit List will be prepared from 100 marks of Written Examination. For each wrong answer 0.25 marks well be deducted. 33% will be the passing cut off in the written examination.
- 11) The closing date for submission of application will be the crucial date for meeting eligibility conditions including age and educational qualifications. The candidate

should have received certificate / mark sheets before the closing date of submission of application

12) Candidature of the candidate found to be using unfair means will be cancelled automatically and further action including debarring from all future exams and criminal proceeding may be initiated

13) Admission of the candidate to examination centre.

14) Penalty:

- j. Harassing or causing bodily harm to the staff employed/engaged by the Board for the conduct of the examination; or will be proceeded against as per the available penal and disciplinary provisions. The candidate will also be debarred from giving the examination.
- 15) Candidature of the candidate shall be cancelled, if he/she found guilty after screening of CCTV footage.
- 16) For Group "B" post, the reservation concession belonging to the Scheduled Castes / Scheduled Tribes and Other Backward Classes should be on all India basis. The Candidates belonging to SC/ST/OBC should submit the Scheduled Castes / Scheduled Tribes Certificate / latest Non crème layer certificate issued by the Competent Authority.
