I. COMPANY PROFILE

- (a) Indo-Russian Rifles Private Limited (IRRPL) is an assault rifle-manufacturing facility in Korwa, Amethi district, Uttar Pradesh, India. This Joint Venture was incorporated in 2019 under Inter Governmental Agreement for manufacturing AK–203 assault rifles for the Indian Armed Forces. It is a JV between Advanced Weapons and Equipment India Limited (42.5% stake), Munitions India Limited (8% stake), Concern Kalashnikov (42% stake) and Rosoboronexport (7.5% stake).
- (b) Its registered office is at 301A, Statesman House, Barakhamba Road, New Delhi 110001, CIN Number U29100DL2019PTC346537. The paid up capital of the company is Rs. 100 Crore.

II. JOB DESCRIPTION AND RESPONSIBILITIES

The CEO/MD shall be the Chief Executive of the Company and will report to the Board of Directors. The CEO will be one of Directors and shall be designated as Managing Director (MD). The CEO/MD shall function under the superintendence, control and directions of the board and in accordance with the Articles of Association of the company. The day to day management of the company will be carried out by the CEO/MD.

III. ELIGIBILITY

(a) **Qualification:** The applicant should be an Engineering Graduate/ Post Graduate in any discipline.

(b) Experience:
