- 3. Repeal of Provision for Contractual Employees:-**


Pursuant to Odisha Group-B, C and Group-D posts (Repeal and Special Provisions) Rules, 2022 notified vide Government in GA & PG Department Notification No.29076/Gen. dated 16.10.2022, the Clause-3 (c) (c), Para-9 of Annexure-A under the clause 'pre-requisites for filling of online application form' and the said clause elsewhere in the advertisement is hereby deleted.

4. The following Provisions in Clause-4 (a) of advertisement are added

In-continuation to Clause-4 (a) of advertisement, the Main Written Examination for all Technical Papers of Combined Technical Service Recruitment Examination -2022 shall be of objective (MCQ) type.

5. As per Minimum Education Qualification for the post of Assistant Training Officer (Diploma) at Clause-2 (a) of advertisement "candidates having 03 years Diploma in respective branches are eligible to apply for the post". However the candidates who have completed 02 years Diploma through lateral entry are also eligible to apply for the post.
6. All other terms and conditions of the advertisement remain unaltered.
