2. The appointment of the above selected candidates is subject to

2.1 Re-verification of original certificates with respect to proof of age, caste, category, educational qualification, Heavy Motor Vehicle Driving License and verification of their character and antecedents.

2.2 Satisfactory verification of their Ex.-Serviceman Identity Card & Discharge certificate and Sports Identity Card issued by the Director, Sports and Youth Services Department, Odisha of the candidates selected under "Ex.-Serviceman" and "Sports person" categories respectively.

2.3 Submission of a medical fitness certificate issued by an authorized Govt. Medical Officer.

2.4 Submission of formal Relieve Order of resignation from service issued by previous employer of any Govt./ PSU/ State PSU/ Govt. funded autonomous bodies etc., if the candidate is employed in Govt./ PSU/ State PSU/ Govt. funded autonomous bodies etc.

3. Their appointment is purely temporary and can be terminated at any time without assigning any reason thereof.

4. The selected candidates shall be on probation for a period of nine months from the date of their joining or passing final examination of basic Fireman Driver Course of training whichever is later in terms of Rule 18 of Home Deptt. Notification No.30030/CD dtd.25.08.2021.

5. All the above 112 newly selected Fireman Driver candidates will report at OFDRA, Bhubaneswar on 12.02.2024. at 10 A.M. On reporting, the candidates will submit their joining report.

6. The candidates shall bring the following documents for reporting/ joining.

- a. Self-attested six recent passport size photographs
- b. Self-attested Xerox copy of PAN card with account details
- c. Proof of Identity from Adhar Card/ Voter ID/ Passport/ DL
- d. Admit Card issued by Fireman & Fireman Driver Recruitment Board.
- e. Medical Certificate obtained from a Govt. Medical Officer.
- f. Formal Relieving Order of acceptance of resignation from service issued by previous employer of any Govt./ PSU/ State PSU/ Govt. funded autonomous bodies etc., if the candidate was earlier employed in Govt./ PSU/ State PSU/

Govt. funded autonomous bodies etc. Mere copy of the letter of resignation will not be accepted.

7.

They are required to purchase Fire & Emergency Service uniform and accoutrement, messing expenses and accordingly require an expenditure of approximately **Rs.5000**/- in advance. They shall come prepared with that.

- 8. The selected candidates appointed as Fireman Driver of Fire & Emergency Service will undergo basic Fireman Driver course of training for a period of nine months at the designated training Academy/ Institute as decided from time to time.
- 9. The Fireman Driver so appointed are liable to be discharged at any stage of their training, if their progress in monthly or periodical assessment is found unsatisfactory or they otherwise render themselves unfit by their actions or if they are found unsuitable for Fire & Emergency Service without previous notice as per Rule-18 (3) of Odisha Fire Service (Methods of Recruitment and Conditions of Service of the Group 'C' Officers) Rules, 2021.
- 10. They should be fit to attend parade and physical lessons throughout the Training period. Any report from a Doctor declaring any of the candidate is unfit to undergo lessons for any length of time will make him liable for discharge from service.
- 11. The *inter-se*-seniority in the rank of Fireman Driver of Fire & Emergency Service will be determined as per Odisha Fire Service (Methods of Recruitment and Conditions of Service of the Group 'C' Officers) Rules, 2021 notified vide Home Deptt. Notification No. 30030/CD dtd.25.08.2021.
- 12. It is again reiterated that the appointment is purely provisional subject to verification of original documents and medical fitness for basic Fireman Driver Course of training/ service as mentioned in aforesaid paragraphs.
