3. General Ability:

In order to be eligible for engagement to the above post a candidate must satisfy the following conditions also. He/ She

- a) Shall be a citizen of India.
- b) Shall have good moral Character.
- c) Shall be of good health, good physique, active habits and far from any organic defect or bodily deformity(Not applicable in case of persons with disability)
- d) Must be able to speak, read and write Odia fluently and must have passed an examination in odia language equivalent to that of Middle School standard.
- e) Must not more than one spouse living .

4. **Age Limit:** There quired age of candidates as on the first day of the year of the publication of recruitment notice shall be with limit to lower age 21 years and upper age 45 years.

5. Procedure and Selection:

- I. The recruitment shall be on the basis of Career Marking only as per weightage assigned below.

- II. The merit list shall be drawn up on the basis of weight age percentage of marks obtained in all the 6 categories mentioned in the table above. In case more than one candidate has equal marks, the candidate with past experience of working in Child Right will be given preference. The decision of the Selection Committee shall be final in this regard.

6. Method of Engagement:

- A. The Selection Committee shall make and recommend the name of 5 candidates for each position in order of preference to the Governing Body/management of the institution for appointment against vacant positions. The candidates scoring the highest marks will be called for a verification of certificates prior to issue of appointment order. The Panel will be valid for 1 year from the date of finalization.
 - B. Formula for conversion of Grade Point (CGPA) into % of marks be provided otherwise the institution will follow its own conversion formula.
 - C. The Management of CCI will be the authority to issue the engagement order to the staff. The management will decide the continuance of service of its staff based on the annual performance appraisal.
7. The posts are purely temporary, Contractual, time bound and coterminous with the scheme or depending on the satisfactory performance whichever is earlier.

8. Documents to be sent along with the application form:

- a. Self-attested photocopy of Secondary, HSC, and Graduation, Post Graduation or other professional qualification certificate and mark sheet.
- b. One recent self-attested colour photograph (3.5x4 size) should be affixed to the application form.
- c. Certificate of experience issued from previous employer, as applicable for the post.
- d. Self-declaration regarding non-involvement in any criminal activities especially child-related offences.

N.B:- A separate application has to be submitted for each post mandatorily quoting the position on the top of the envelope **“FOR THE POST OF.....”**, otherwise, it shall be rejected.
