Second Provisional Merit List of Selected Candidates B.A.LL.B.(Hons.) Programme

- The Registration process of Online Counselling for admission to B.A.LL.B.(Hons.) Programme at National Law University Delhi was started on Tuesday, December 20, 2022 with last date for Online Counselling Registration as December 26 2022.
- **The First Provisional Merit List of Selected Candidate (category wise) was issued on December 30, 2022. The last date payment of confirmation of provisional admission was January 4, 2023. The Waiting List of candidates was also issued on December 30, 2022.**
- **Based on the available vacancies, the Second Provisional Merit List of Selected Candidate (category wise) for admission to B.A.LL.B.(Hons.) Programme is annexed as Annexure-A.**
- **The candidates who appear in the Second Provisional Merit List of Selected Candidates for the B.A.LL.B.(Hons.) Programme (ANNEXURE-A) should pay a sum of Rs.50,000.00 as Provisional Admission Confirmation Fee on or before Wednesday, January 11, 2023 failing which the offer of admission shall stand cancelled and the seat will be offered to the next candidate in order of merit under concerned category from the Waiting List.**
- **The portal/interface for payment of Provisional Admission Confirmation Fee & downloading of Provisional Admission Offer Letter by the provisionally selected candidates will be activated from 2:00 P.M. on Friday, January 6, 2023.**
- In case, the candidates do not accept the offer of admission for any reason whatsoever, it will not be considered afterwards under any

circumstances and they will forfeit the right of admission along with the right to refund the Counselling Fee. No request shall be entertained in this regard.

- In case, any vacancy arises due to withdrawal of admission or non-payment of Provisional Admission Confirmation Fee by the provisionally selected candidates within the stipulated time-period, the seat shall be filled up from the Waiting List candidate(s) only.
- The provisionally selected candidates are also required to download their Provisional Admission Offer Letter from their AILET-2023 account. In token of acceptance of provisional admission offer, the candidate shall sign each page of provisional admission offer letter and upload the same on the AILET-2023 account along-with the undertaking duly signed by the candidate and parents.
- The provisionally selected candidates are also required to upload their Marks Statement of XII Class Examination or equivalent Examination on their AILET-2023 account. **In case the candidate is appearing in the XIIth Class examination in the month of March/April 2023, an undertaking is to be uploaded by the such candidates in the proforma provided as ANNEXURE-C**
