pursuant to Employment Notice No. 02/2022)

In view of resolution of the 'Centralized Selection & Appointment Committee' dated 08.04.2024 duly approved by the Hon'ble Court, the following are published in connection with '**Written Test**' held on **17.12.2023** regarding appointment to the post of **Stenographer** in the Civil Courts of Bihar pursuant to the **Employment Notice No. 02/2022** -

- (i) The **list of 3345 qualified candidates** in the **written test** is being **published** below for information to the concerned candidates as **Annexure - A.**
- (ii) The **list of 4349 disqualified candidates** in the **written test** is being **published** below for information to the concerned candidates as **Annexure - B.**
- (iii) The **list of 365 candidates**, whose either '**OMR sheets**' found **invalid** (as per instructions given in the OMR sheet of the written test) or '**Answer Book**' which has been **cancelled** (as per instructions given in the answer book of the written test) or who have **not submitted the 'Answer Book'** in connection with **written test** is being **published** below for information to the concerned candidates as **Annexure - C.**
- (iv) The **result** of Written Test of one candidate bearing Roll No. **203436** is kept **pending.**
- (v) The '**Skill Test**' of **3345 qualified candidates will be held on 08.05.2024 in Patna.** The **candidate** may **download** their respective **admit card** from the link provided on the website of the Civil Courts, Patna, which shall be made available from **01.05.2024.**
- (vi) The **mode and manner** of the '**Skill / Typing Test**' & '**Computer Proficiency Test**' is as follows -
- For English Stenographer -**
1. **Shorthand Test** (25 marks) - The candidates will be given a dictation of 400 words in 5 minutes to note down in shorthand and 45 minutes will be given to type the same.
 2. **Typing Test** (15 marks) - The candidates have to type **400 words** with **typing speed of 40 wpm in English.**
 3. The candidates have to use the '**Qwerty**' Keyboard Layout of '**Times New Roman**' font for **English typing.**
- For Hindi Stenographer -**
1. **Shorthand Test** (25 marks) - The candidates will be given a dictation of 300 words in 5 minutes to note down in shorthand and 45 minutes will be given to type the same.
 2. **Typing Test** (15 marks) - The candidates have to type **300 words** with typing speed of **30 wpm in Hindi.**
 3. The candidates have to use the '**Remington Gail**' Keyboard Layout of '**Mangal**' font for **Hindi typing test.**

For Bilingual Stenographer -

1. Shorthand Test -

- a. **Hindi** (12.5 marks) - The candidates will be given a dictation of 300 words in 5 minutes to note down in shorthand and 45 minutes will be given to type the same.
- b. **English** (12.5 marks) - The candidates will be given a dictation of 400 words in 5 minutes to note down in shorthand and 45 minutes will be given to type the same.

2. Typing Test -

- a. **Hindi** (7.5 marks) - The candidates have to type **300 words** with typing speed of **30 wpm in Hindi**.
- b. **English** (7.5 marks) - The candidates have to type **400 words** with **typing speed of 40 wpm in English**.

3. The candidates have to use the '**Remington Gail**' Keyboard Layout of '**Mangal**' font for **Hindi typing test** and the '**Qwerty**' Keyboard Layout of '**Times New Roman**' font for **English typing**.

Further, the typing mistakes may be assessed as follows-

NATURE OF MISTAKES

A. Full mistakes: The **following errors will be treated as full mistakes-**

- Every omission of word / figure.
- Every substitution of a wrong word / figure.
- Every addition of a word / figure not found in the passage.

B. Half mistakes: The **following errors will be treated as half mistakes-**

- **Spacing Errors:** Where no space is provided between two words, e.g. 'Ihope' or undesired space is provided between the words or letters of a word e.g. hope I have, 'I hxxave'.
- For every spelling error committed by way of repetition, or addition or transposition or omission or substitution of a letter / letters, e.g. the word 'spelling' typed as 'seeplings' etc.
- **Wrong Capitalization:** Wrong use of capital letter for small letter and vice-versa. (This does not apply to Hindi typewriting scripts).

C. Any correction made by pen or pencil will be ignored and no credit will be given for such corrections.

'Computer Proficiency Test' for Hindi / English / Bilingual Stenographer

(10 marks)-

The knowledge of candidates about **M.S. Word & M.S. Excel** will be assessed through **practical** on the software and their **Internet Surfing skills** will be assessed through **multiple choice questions**.

(i) The instruction no. 4 mentioned in the OMR sheet is as follows-

“4. Please fill up this OMR sheet carefully according to instructions. The candidate marking his/her Roll Number and Series incorrectly, will make the OMR sheet invalid which will not be evaluated.”

(ii) The ‘INSTRUCTIONS TO CANDIDATES’ printed on the answer sheet of the written test and found that at sl. nos. 2 & 5 of the same are follows-

“2. In the space marked ‘(i)’ of the answer book, candidates must write their Name, Roll No., Centre and put their full signature in English. Space marked ‘(ii)’, ‘(iii)’ and ‘(iv)’ are of office use only, nothing should be written in these spaces, otherwise the answer book will be cancelled.

5. Candidate must use only Black/ Blue ink for writing answer. If Roll Number / name or any mark of identification appear and / or ink of any other colour except Black / Blue or pencil is used anywhere else except the space ‘(i)’ of the answer book, the answer book will be cancelled.”

In view of resolution of the **Centralized Committee dated 08.04.2024** considering the above facts, duly approved by the Hon’ble Court, the **OMR sheets** of candidates as mentioned in the aforesaid list, who had made error in filling OMR sheet, **cannot be evaluated**, as the same is **invalid** and the **answer book** of candidates as mentioned in the aforesaid list, be declared as **cancelled**.
