Emmerson Mnangagwa Wins Second Term As President **Of Zimbabwe**

Emmerson Mnangagwa has been declared the winner of Zimbabwe's presidential election, securing a second term as the nation's leader. The Zimbabwe Electoral Commission (ZEC) announced Mnangagwa as the victor with 52.6% of the vote, while his closest rival, Nelson Chamisa of the Citizens' Coalition for Change (CCC), trailed behind at 44%. This election marks a significant moment in Zimbabwe's political landscape, occurring six years after the fall of longtime ruler Robert Mugabe, who was ousted from power in a military coup. Born on 15 September 1942, Emmerson Dambudzo Mnangagwa is a prominent Zimbabwean politician who assumed the role of Zimbabwe's President on 24 November 2017. A dedicated member of (Zimbabwe African National Union-Patriotic Front) ZANU-PF and a close associate of former President Robert Mugabe, Mnangagwa occupied various key ministerial positions and served as Mugabe's Vice-President until November 2017. Taking the helm at the age of 80, Mnangagwa's ascendancy followed a 2017 military coup that deposed Zimbabwe's longstanding leader, Robert



Mugabe, who had held authority since the country's independence in 1980. During the mid-1980s, Mnangagwa held responsibility for internal security. Mnangagwa was nicknamed as "The Crocodile," a creature renowned in Zimbabwean legend for its cunning and unyielding nature."

Russia Launches Islamic Banking Pilot Program: Exploring Shariah-based Finance

Russia is set to embark on a historic journey by launching its first Islamic banking pilot program on September 1. With a considerable Muslim population of approximately 25 million, the move aims to tap into the potential of Islamic finance, which has already had a presence through institutions but lacked official recognition. President Vladimir Putin's recent endorsement of the initiative signifies a significant step towards embracing Islamic banking principles in the country. **Tharman Shanmugaratnam Wins Singapore Presidential Election**

In a significant political development, Indian-origin economist Tharman Shanmugaratnam has emerged victorious in Singapore's presidential election. This victory is especially noteworthy as it comes after a gap of ten years, marking the country's first contested presidential polls since 2011. Tharman Shanmugaratnam secured a substantial majority in the presidential elections, receiving a resounding 70.4 percent of the votes. His victory was achieved against two other contenders of Chinese origin, Ng Kok Song and Tan Kin Lian, who garnered 15.7 percent and 13.88 percent of the votes, respectively. Tharman Shanmugaratnam, the president-elect, entered the realm of politics in 2001. During his campaign, he articulated a vision for Singapore, promising to cultivate the country's culture and uphold its standing as a "shining spot" on the global stage. Shanmugaratnam, aged sixty-six, previously held the position of Singapore's Deputy Prime Minister from 2011 to 2019. His political journey began in 2001, and he has also made significant contributions in the public sector, holding various ministerial positions.

Assam Cabinet Creates 4 New Districts, 81 Sub-Districts After Delimitation

In a significant move aimed at enhancing decentralization of governance and improving the convergence of line departments, the Assam cabinet has taken a bold step by creating four new districts that were previously abolished last year in December. Nagaland Becomes First State In North Eastern Region To Initiate Aadhaar Linked Birth Registration

Nagaland has taken a pioneering step in the North Eastern region by launching the Aadhaar-Linked Birth Registration (ALBR) system. This groundbreaking initiative focuses on simplifying the procedures of birth registration and Aadhaar enrolment for children aged 0 to 5 years. The commencement of the launch was formally led by Commissioner T Mhabemo Yanthan. During the launch event, there was a live demonstration that resulted in the successful registration of two newborn infants. This achievement represents a noteworthy advancement in guaranteeing that every child can rightfully access social welfare services. The initiative aims to improve the overall journey for both parents and children throughout the crucial phases of birth registration and Aadhaar enrolment. Through ALBR, the process of Aadhaar enrolment occurs simultaneously with birth, seamlessly intertwining it with the registration process. This enrollment method is facilitated smoothly using a tablet under the supervision of (Child Enrolment Lite Client) CELC Operators, necessitating only a proof of relationship document for enrolling the child.

Kolkata Becomes 3rd Indian City To Get Air Quality Early Warning System

The Indian city of Kolkata has taken a significant step forward by adopting an Air Quality Early Warning System (AQEWS), developed by the Indian Institute of Tropical Meteorology (IITM) based in Pune. This system offers both real-time air pollution data and forecasts, with the objective of enhancing readiness and facilitating measures to tackle the escalating air pollution levels within the city. The AQEWS in Kolkata comes equipped with an intricate network of sensors that monitor the air quality index (AQI) in real-time. This AQI is a standardized metric used to assess the level of air pollution in a specific area, with values ranging from 0 to 500. A higher AQI indicates more polluted air and an increased health concern. The AQEWS provides this data by analyzing the concentration of pollutants like PM2.5 (particulate matter with a diameter of 2.5 micrometers or smaller), which has been identified as a major contributor to health problems due to its ability to penetrate deep into the lungs.

India's GDP growth accelerates to 7.8% in April-June quarter

In a significant economic development, India's Gross Domestic Product (GDP) demonstrated robust growth, surging to 7.8% in the first quarter of the fiscal year 2023-2024, compared to a 6.1% growth rate recorded in the preceding January-March quarter of the fiscal year 2022-23. This acceleration is indicative of a positive economic trajectory and holds great implications for the nation's financial landscape. Looking back at the same quarter in the previous year, the GDP growth rate stood at a remarkable 13.1%. This highlights both the progress and the challenges that the Indian economy has faced over the past year. The impressive Q1FY24 economic growth can be attributed primarily to the exceptional performance of the services sector, which has displayed remarkable resilience and adaptability. Additionally, a surge in capital expenditure has contributed significantly to this growth trajectory.

All-India House Price Index Surges 5.1% in Q1FY24: RBI's Latest Data

The Reserve Bank of India (RBI) has unveiled its latest data, revealing a significant upswing in the All-India House Price Index (HPI). In the April-June quarter of the fiscal year 2023-24, the HPI recorded a robust growth rate of 5.1%. This marks a noteworthy increase compared to the 3.4% growth observed during the same period in the previous year. The **R**BI's guarterly HPI report draws upon transaction-level data sourced from registration authorities in ten major cities across India. These cities include Ahmedabad, Bengaluru, Chennai, Delhi, Jaipur, Kanpur, Kochi, Kolkata, Lucknow, and Mumbai. The growth trends within these cities exhibit considerable diversity. Delhi Leads with 14.9% Growth: Among the cities, Delhi stands out with an impressive annual HPI growth rate of 14.9%. This substantial increase underscores the city's robust real estate market. Kolkata Witnesses a Contraction: In contrast, Kolkata experienced a decline in house prices, with a contraction of 6.6%. This variation highlights the disparities in housing market performance across different regions.

Zepto is first Indian unicorn of 2023, raises \$200 million at \$1.4 billion valuation

Online grocery delivery startup Zepto has successfully raised \$200 million in a Series-E funding round, achieving a valuation of \$1.4 billion. This achievement marks Zepto as the first unicorn of 2023. The funding was led by StepStone Group, a US-based private markets investment firm, and is StepStone Group's inaugural direct investment in an Indian company. Joining StepStone Group in this funding round is Goodwater Capital, a consumer-focused venture capital firm from California.

Noteworthy is the participation of existing investors, including Nexus Venture Partners, Glade Brook Capital, Lachy Groom, among others, who further solidified their support with substantial follow-on investments.

Zepto, established in response to the pandemic, was founded in 2021 by Aadit Palicha and Kaivalya Vohra, both dropouts from Stanford University.



The startup had previously raised \$200 million in a Series D investment de funding round in 2022, led by Y Combinator's Continuity without req

Fund, which valued the company at \$900 million. Zepto's founders have also expressed their intention to list the company on public markets within the next two to three years.

Tata Steel and ACME Group Join Forces For India's Largest Green Hydrogen Project

In a significant partnership, ACME Group, a prominent renewable energy company, has joined forces with Tata Steel Special Economic Zone Ltd. (TSSEZL) to establish an expansive green hydrogen and green ammonia project within Odisha's Gopalpur Industrial Park. This venture is poised to become the largest facility of its kind in India, marking a significant stride towards sustainable energy production. The project is set to be situated at the Gopalpur Industrial Park (GIP) in Odisha, strategically chosen for its logistical advantages and existing infrastructure. ACME Group has secured 343 acres of land within TSSEZL's GIP to house the green hydrogen and derivatives unit, underlining their commitment to eco-friendly energy solutions. The estimated investment for the entire project amounts to Rs 27,000 crore, to be invested in progressive phases, reflecting the strategic approach to development.

Viacom 18 Secures BCCI TV and Digital Media Rights in a 5-Year Deal Worth Rs 5,963 Crore

Viacom 18, a Reliance-owned media outlet, has emerged victorious in the auction for media rights, encompassing both digital and TV broadcasting, of India's domestic matches and BCCI-hosted domestic tournaments for the next five years. The auction took place on August 31, 2023. This significant acquisition complements Viacom 18's existing digital rights for the Indian Premier League (IPL) and the FIFA World Cup rights for India. Let's delve deeper into the details. Viacom 18 faced fierce competition from Sony Sports Network and Star Sports in the bidding process. Star Sports already held TV rights for ICC events and the IPL, leaving Sony to vie for these coveted rights. For the 88 matches scheduled between 2023 and 2028, the BCCI set a base price of Rs 20 crore per match for TV rights and Rs 25 crore per match for digital rights, totaling Rs 3,960 crore.

Rashtriya Chemicals and Fertilizers Gets Navratna Status The Department of Public Enterprise (DPE) conferred 'Navratna Status' upon Rashtriya Chemicals and Fertilizers (RCF). Navratnas constitute a group of public sector firms endowed with the financial independence to invest up to Rs 1000 crore without necessitating approval from the central government. Prior to this, the company had attained 'Miniratna Status' from the Department of Public Enterprise. Navratna Companies, a select group of nine esteemed public sector enterprises in India, are renowned for their outstanding performance and significant contributions to the nation's economy. These companies enjoy substantial financial independence, granting them the authority to make investment decisions for projects up to a specific threshold without requiring government approval. Navratna Companies, classified as Central Public Sector Enterprises (CPSEs), are subject to specific operational and financial criteria based on factors such as net profit, total production cost, earnings per share, and cross-sector performance.

CCI Clears Air India-Vistara Merger

The Competition Commission of India (CCI) has recently given the green light to the merger of Tata SIA Airlines, which operates under the Vistara brand, with Air India, a subsidiary of Tata Sons Pvt. Ltd. This landmark merger also involves Singapore Airlines (SIA) and entails the acquisition of shares in the merged entity, Air India, subject to certain voluntary commitments. TSAL (Tata SIA Airlines Limited) is a joint venture between the Tata Group and the Singapore Airlines with the former holding 51% and the latter 49%. Tata Sons Pvt. Ltd. made headlines in January 2022 when it acquired Air India through its subsidiary, Talace Pvt. Ltd. This move signaled Tata's resurgence in the Indian aviation sector, setting the stage for what was to come. The subsequent merger with Tata SIA Airlines, also known as Vistara, is poised to create a formidable force in the Indian skies.

GSL and Kenya Shipyard Ltd Sign MoU For Collaboration In Shipbuilding

With its efforts to enhance security of the Indian Ocean Region (IOR), especially on the eastern coast of Africa, a Memorandum of Understanding (MoU) was signed between Goa Shipyard Limited (GSL) and Kenya Shipyards Limited (KSL) to strengthen maritime security cooperation between the two nations. The agreement focuses on capacity building and collaboration in ship design and construction. The MoU was formalized in the presence of India's Defence Minister Rajnath Singh and Kenya's Cabinet Secretary for Defence Aden Bare Duale during their talks in New Delhi. This signing reflects the shared commitment of both nations to deepen their collaboration in maritime security. As one of the largest exporters of defence ships from the Indian subcontinent, GSL brings a wealth of experience and expertise to the partnership. On the other hand, Kenya Shipyards Limited was established by Kenya's National Security Council in August 2020 to address the operational requirements of the Kenyan Navy.

NITI Aayog and UNDP Collaborate to Accelerate SDGs in India

The National Institution for Transforming India (NITI Aayog), the central think tank responsible for monitoring India's progress towards Sustainable Development Goals (SDGs), and the United Nations Development Programme (UNDP) have signed a significant Memorandum of Understanding (MoU) aimed at expediting India's journey towards achieving its SDGs. This collaboration underscores the commitment to

Former CJI NV Ramana appointed as member of International Mediation Panel

Former Chief Justice of India (CJI) N.V. Ramana has been appointed as member of the International Mediator Panel of Singapore International Mediation Centre (SIMC). Chairman of SIMC George Lim presented Justice Ramana the letter of appointment on Tuesday in Singapore. The former CJI is in Singapore to take part in the "Singapore Convention Week", the annual convention organised by Singapore's Ministry of Law, the United Nations Commission on International Trade Law (UNCITRAL) and over 20 partner organisations. Justice Ramana met representatives of SIMC and four top Indian corporate majors Tata, Reliance, Mahindra and Aditya Birla groups, who came forward to sign 'Declaration of Intent' to support mediation at the initiative of Justice Ramana.

Geetika Srivastava becomes India's First Woman Charge d'Affaires In Pakistan

Geetika Srivastava, currently serving as joint secretary at the headquarters of the Ministry of External Affairs (MEA), will be India's new chargé d'affaires at its high commission in Islamabad, Pakistan. She will succeed Suresh Kumar, who is likely to return to New Delhi. After 77 years of Independence, India has appointed a female head of mission in Pakistan. The appointment of Geetika Srivastava as the new CDA in Islamabad signifies a progressive step by the Indian government as it breaks the traditional male-dominated pattern of diplomatic appointments to Pakistan. This is a significant move as Srivastava will be the first woman to lead the Indian High Commission in Pakistan, reflecting a commitment to gender equality and empowering women in leadership roles.

ISRO Aditya L1 Mission Launched

ISRO Aditya L1 mission was launched successfully on September 2, 2023 at 11:50 AM IST from the Satish Dhawan Space Centre in Sriharikota, India. The mission is India's first dedicated solar mission and will study the Sun's atmosphere, including the chromosphere and corona. It will also study the solar wind and its interaction with the Earth's atmosphere. The Aditya L1 spacecraft is a 1.5-ton satellite that is equipped with seven payloads. The payloads will study the Sun's atmosphere using a variety of methods, including remote sensing and in-situ measurements. The spacecraft will be placed in a halo orbit around the Sun-Earth Lagrange Point 1 (L1), which is located about 1.5 million kilometers from Earth.

The Aditya L1 mission is expected to last for five years. During this time, it will collect valuable data about the Sun that will help scientists to better understand its behavior and its impact on Earth.
