Pradhan Mantri Fasal Bima Yojana (PMFBY)	 Key Points: The Pradhan Mantri Fasal Bima Yojana (PMFBY) is the main crop insurance scheme implemented in Tamil Nadu. It is a comprehensive crop insurance scheme that provides financial protection to farmers against crop losses due to natural calamities, pests, and diseases. Under PMFBY, farmers can insure their crops against a variety of risks, including: Yield loss due to drought, flood, hail, lightning, fire, pest attack, and diseases Pre-sowing and post-harvest losses Localized calamities PMFBY is a subsidized scheme, with the government paying 50% of the premium for Kharif crops and 90% of the premium for Rabi crops.
Dr. Muthuletsumi Reddy Maternity Funding Scheme.	 Context: Minister of Public Welfare M.Subramanian said that Rs.14,000 in cash and Rs.4,000 worth of nutrition fund will be given in 3 installments under the Maternity Fund Scheme in Tamil Nadu. Key Points:

Muthulakshmi Reddy Maternity Benefit Scheme (MRMBS)	 Dr. Muthuletsumi Reddy Maternity Funding Scheme and Prime Minister Mathru Vandana Yojana Scheme 2.0 were jointly launched by Minister M. Subramanian. Dr. Muthuletsumi Reddy Maternity Funding Scheme: It is a social welfare scheme launched by the Government of Tamil Nadu in 2006 Under this scheme, the beneficiaries are given Rs.18,000 (Central Government Rs 3,000, State Government Rs 15,000) It was being paid in five installments for the first two deposits but now will be paid in 3 installments.
Yojana Scheme 2.0	 It is a Centrally Sponsored Scheme of the Ministry of Women and Child Development (MWCD), Government of India. It was launched on 1st April 2022 with the objective to provide financial assistance to pregnant women and lactating mothers for improved health seeking behavior amongst them. The scheme provides a cash incentive of Rs. 5000/-to all eligible pregnant women and lactating mothers for the first living child
Courts should be guided by constitutional morality	 In News: Senior counsel P Wilson contended that the court has to be guided by constitutional morality and not by societal morality, while defending Minister Udhayanidhi Stalin in a quo warranto petition filed by Hindu Munnani.
