Ms. No.3, Backward Classes Welfare (C-2) Department, Dt:04-04-2006 and G.O.Ms.No.26, BC Welfare (C) Dept., Dt: 09-12-2013) who claim reservation under BC Community and Sports Category certificate etc.**, failing which, they will not be treated as eligible with reference to the particulars furnished by him/her in the Online Application Form / Certificates.
