	<p>Key Points:</p> <ul style="list-style-type: none">• The Prajavani program is a public grievance redressal program launched by the Government of Telangana in 2014.• The program aims to provide a platform for citizens to air their grievances and seek redressal from government officials.• Under the Prajavani program, all government officials, including the Chief Minister, Ministers, and District Collectors, are required to hold public hearings on a designated day of the week.(Friday)• During these hearings, citizens can meet with officials and submit their grievances in person.• Grievances submitted under the Prajavani program are tracked through an online portal.
<p>Telangana High Court declines to invoke Article 226 for land encroachers</p>	<p>In News:</p> <ul style="list-style-type: none">• The Telangana High Court held that it was not inclined to invoke the extraordinary jurisdiction of the constitution under Article 226 for the sake of land encroachers. <p>Key Points:</p> <ul style="list-style-type: none">• Speaking for the bench, Chief Justice Alok Aradhe commented that the encroachers in fact should have been dispossessed from the government lands, however with all magnanimity, it is permitting individuals to regularize.• It also observed that regularization is purely a government policy and the petitioner should pay the charges demanded.

About Art 226

Key Points:

- **Article 226** of the Indian Constitution empowers the High Courts to issue writs, for the enforcement of fundamental rights or for any other purpose.
- **Habeas corpus**: A writ of habeas corpus is issued to a person who has detained another person, directing them to produce the detained person before the court and to show cause for the detention.
- **Mandamus**: A writ of mandamus is issued to a public authority or official, directing them to perform their duty.
- **Certiorari**: A writ of certiorari is issued to a lower court or tribunal, directing them to send the record of a case to the High Court for review.
- **Prohibition**: A writ of prohibition is issued to a lower court or tribunal, prohibiting them from proceeding with a case.
- **Quo warrant**: A writ of quo warrant is issued to a person who is holding a public office, questioning their right to hold that office.
