Accepting the request of the AP government, the Tribunal posted further hearings to November 22. <p>Key Points:</p> <ul style="list-style-type: none"> The Brijesh Kumar Tribunal in its order said that the counsel on behalf of Andhra has requested that some time may be allowed to study and consider the impact and legality of the present reference made to this Tribunal vide notification dated October 6, 2023, and sought adjournment for the purpose. The request was opposed by Telangana. The Telangana counsel submitted that Andhra may file a reply/statement of case in response to the present reference. It also submitted that a time frame may be provided for the purpose.
