SEZ units are not exempt from compensation cess under GST	 The AP High Court has ruled that units in Special Economic Zones (SEZs) are not exempt from paying compensation cess under the Goods and Services Tax (GST) on imported goods. The court also emphasized that the SEZ Act of 2005 is a self-contained law providing exemptions, and for Section 7 to apply, the tax or cess must be referenced in the First Schedule of the SEZ Act. As the GST Compensation cess is not mentioned, the court held that it is not exempt for SEZ units. About: Cess is a type of tax levied by governments, traditionally for specific purposes like promoting education, health, or social development. It's distinct from regular taxes as it's typically an additional levy on an existing tax base.
