Capacity: A 1,100 MW coal-fired power project with two units: <ul style="list-style-type: none"> Unit 1: 500 MW capacity Unit 2: 600 MW capacity <p>Record Achievement:</p> <ul style="list-style-type: none"> Uninterrupted Operation: The 600 MW unit of Kakatiya Thermal Power Plant (KTPP) operated continuously for 202 days from December 15, 2023, to July 4, 2024. Plant Load Factor (PLF): Achieved a PLF of 85.36%. Electricity Production: Generated approximately 2,460.2 million units of electricity in 202 days. <p>History and Commissioning:</p> <ul style="list-style-type: none"> Inception: The KTPP Plant commenced operations in 2009. <p>Impact of Centre's New Clause on Off-Budget Borrowings in Telangana</p>	<p>Context:</p> <ul style="list-style-type: none"> • Telangana's efforts to secure funds for schemes like crop loan waivers face challenges due to recent changes in off-budget borrowing guidelines by the Centre. • In 2022, the Centre reclassified Telangana's off-budget borrowings of 35,000 crore as budgeted borrowings under new fiscal guidelines. • This reclassification reduces the state's borrowing capacity for both budgeted and off-budget borrowings. <p>New Guidelines and State Response:</p> <ul style="list-style-type: none"> • The Centre's decision stemmed from concerns over fiscal responsibility, aligning with the Fiscal Responsibility and Budget Management Act (FRBM). • Off-budget borrowings by state-run corporations, guaranteed by the state government, now count towards the state's borrowing limits. • Telangana, along with Kerala, faces significant constraints under these regulations, complicating future off-budget borrowing attempts.
